The village site, now a US Forest Service campground, is also where the largest Winnemem massacre occurred at the hands of European gold seekers in the 1800s. Benin's Sacred Forest Protection Law (2012) In 2012, the West African country of Benin passed national legislation granting legal recognition to community sacred groves. The law prohibits tree cutting and other destructive activities, creates buffer zones around sacred forests, and designates community management committees.
